### Product description:

Agrihance-V is foliar-applied, during the plant's vegetative growth stage giving your crop the specific nutrients it needs from post-emergence to reproduction. The unique no-burn formula and tank-mix flexibility boosts performance without crop injury or making an extra pass through the field.

### Directions for use

- Can be used in-furrow, foliar, 2x2, and y-drop.
- Apply Monty's Agrihance-V (Vegetative) at 1-2 quarts per acre. Can also be applied as a program with Agrihance-S and Agrihance-R. May be applied with most chemical applications.
- Best if used with other Monty's products including starters, foliars, micronutrients, and biologicals. Ask your representative about specialized programs.

Knowing the chemical's "mode of action" (block photosynthesis) or metal content (copper based) will help determine the compatibility of Monty's.
